FAMILY PASS ELIGIBILITY

"Family" is defined as all immediate family members residing at the same address - this would include full-time college students, stepchildren, adopted children and foster children. It does not include babysitters or visiting relatives (sons, daughters, cousins, grandchildren, grandparents, etc.) In order to participate in a family membership, such persons must be claimed as a dependent to the IRS by the person making the application for membership.

CAREGIVER PASS ELIGIBILITY

"Caregiver" is defined as an individual age 14 years or older who will be attending the aquatic facility with your child(ren). The caregiver need not be related. Only one caregiver per family membership is permitted and must be purchased in conjunction with a family membership.

- 2. Grandchildren who are permanently residing at the home of a grandparent for the entire summer.
