# **City Launches Comprehensive Planning Process**

## What is a Comprehensive Plan?

A comprehensive plan is a futuristic vision of City developments, goals and aspirations. It reflects the community's collective vision and provides direction for the future development. The written plan compiles policy statements, goals, standards and maps for guiding the physical, social and economic development for Fairmont.

City officials, land owners and business developers use the plan to help guide them as they make decisions about development of the City. The plan provides justification for the City's future land use and zoning districts. The most recent comprehensive plan for Fairmont was adopted in 2008 and needs updating.

Child care is an economic driver for rural communities. The Fairmont Economic Development Authority (FEDA) realizes this and has begun work to alleviate our local shortage of 172 licensed full-time childcare slots in Martin County – 72 of which are within the City of Fairmont. This is not just a child care issue, it is also a workforce issue. Those unable to find acceptable childcare may decide to exit the workforce.

Due to these challenges, a Core Team from Fairmont has assembled to develop solutions. Initially, this group seeks to better understand the local opportunities and challenges of a child care shortage. 
# New Officer Joins Fairmont Police Force

Fairmont has a new officer, but he isn't one of the typical "boys in blue". He is furry, four-legged and his nose is his best weapon. Titus, a 22 month old German Shepherd, recently completed a 12 week K-9 training program with the Minneapolis Police Department. He reports for duty with Sergeant Tietje and with Tietje's lead, Titus can track, conduct article searches, apprehend criminals and sniff out controlled substances. In addition to working together, Titus and Tietje train monthly for a minimum of 16 hours and participate in an annual certification process through the United States Police Canine Association (USPCA).

Titus is anticipated to be on duty for the next 8 years, after which he will retire and enjoy life as a pet.
