### <u>Cedar Creek Park: 3500 Cedar Park Road</u>

- Tables and chairs to seat approximately 90 people
- Stove, refrigerator, microwave and sink
- 12' serving counter
- Electricity, heat & air conditioning
- Restrooms available in shelter house
- Shelter house is handicap accessible
- Shelter house available for rental year-round

**Lincoln Park: 1325 North North Avenue**\*Weddings take place by the white trellised arbor. Bench seating is set-up for quests to the east so an aisle will be provided for the wedding party.

- Tables and chairs to seat approximately 60 people
- Stove, refrigerator, sink and wide wooden serving table
- Restrooms located across from the shelter house
- Shelter house is **not** handicap accessible

**Sylvania Park: Beach Street**\*includes use of the band shell P.A. system, if requested

- Tables and chairs to seat approximately 55 people
- Stove, refrigerator, microwave and sink
- Electricity, heat and air conditioning
- Restrooms available north of the shelter house
- Chalter house is handisan assessible

# **Park Wedding Reservation** Cedar Creek • Lincoln • Sylvania



## <u>Regulations</u>

- The total wedding charge must be paid at the time of making your reservation.
- Pick-up the shelter house key 1 business day prior to your event. Failure to pick-up the key during City Hall business hours of 8:00 am -4:30 pm will result in a loss of use. No refund will be issued for failure to pick-up the key/loss of
- Please secure the shelter house when you leave. Return the key to City Hall the business day following your rental to avoid late charges.
- Beer kegs are not permitted in the park without a "Keg Permit" which can be obtained at City Hall.
- Refunds will not be issued for inclement weather. Cancellations must take place 2 months prior of the requested reservation date in order to receive a full refund. If the event is cancelled within 2 months of the requested date, all but \$50.00 will be refunded.
- The wedding reservation does not guarantee exclusive use of any other park areas.

Rental hours are from 9:00 am - 11:00 pm. Personal belongings must be removed and clean-up must be completed by 11:00 pm on the reservation date. Staff time for cleaning and/or repairing the facility will be charged at \$50.00 per hour plus the actual cost of materials to repair any damages.
