#### Construct 7-Unit T-Hangar - Construction

AIP #3-27-0029-017-2019

Planning team currently working on Facility Inventory, Master Plan Advisory Committee composition, and Stakeholder Outreach Plan. A Master Plan Advisory Committee kickoff meeting will take place once composition is finalized. The FAA Grant Application has been submitted to the FAA & MnDOT for review/processing on February 16, 2024. No updates on Grant Application have been provided by MnDOT to date.

#### Airfield Pavement Maintenance

The project consists of crack sealing and large crack repairs on all airfield pavements. The project has been awarded and the State Grant has been executed. Construction is planned for the 2024 construction season and KLI is working with the contractor on the proposed startup date.



### Taxiway A Lighting & Signage Replacement - Design

AIP #3-27-0029-023-2024 (Pending)

The Task Order for design has been executed by KLJ and the Airport/City. KLJ is working on the FY24 Entitlement Grant Application for submittal prior to the May 20, 2024 deadline. Design will take place in 2024 with construction anticipated in 2025. KLJ is also currently working on a FY23 Supplemental Discretionary Grant Application for construction of the project for submittal prior to the May 2, 2024 deadline.

#### OTHER ITEMS

- Rehabilitate Terminal Building (Exterior): The City/Airport accepted a state fiscal year 2022 grant for the Rehabilitate Terminal Building (Exterior) project. The work on the project is being coordinated by the City/Airport and is expected to be completed in spring 2024.
- MnDOT CIP/Grant Application Deadline: The MnDOT state grant application deadline is May 1, 2024.
   The City/Airport has coordinated with KLJ on the SFY25 grant applications that will be submitted for projects listed on the current CIP. The CIP will be updated, and grant applications submitted prior to the May 1, 2024 deadline.
