## Airfield Pavement Maintenance

Construction was completed on June 13, 2024. A state grant amendment request was submitted to MnDOT on June 14, 2024 to increase the grant an additional 15% to help reduce the local share. The city received the Grant Amendment Agreement for review and processing on June 24, 2024. KLJ is working with the contractor to complete all final construction paperwork and submit final contractor payment request.

## Taxiway A Lighting & Signage Replacement - Design

KLJ #2205-00853

AIP #3-27-0029-023-2024 (Pending)

The FY24 Entitlement Grant Agreement was received by the city for processing on July 26, 2024. A FY23 Supplemental Discretionary Grant Application for construction of the project was also submitted on May 2, 2024. This grant program is competitive, and no construction funding is guaranteed from the Supplemental Discretionary funding program. Announcements for Supplemental Discretionary grant recipients is anticipated in August 2024. Design will take place in 2024 with construction anticipated in 2025.

- Rehabilitate Terminal Building (Exterior): The City/Airport accepted a state fiscal year 2022 grant for the Rehabilitate Terminal Building (Exterior) project. The work on the project is being coordinated by the City/Airport and is expected to be completed in summer 2024.

A questionnaire was sent on August 30, 2024 to the stakeholders identified by the Master Plan Advisory Committee. A 2<sup>nd</sup> Master Plan Advisory Committee meeting will be scheduled for September or October 2024. City is still awaiting the MnDOT companion grant for this project.

## Airfield Pavement Maintenance

Construction was completed on June 13, 2024 and final payment request was submitted on August 9, 2024 after all construction final paperwork was completed. A state grant amendment request was submitted to MnDOT to increase the grant an additional 15% to help reduce the local share. The Grant Amendment Agreement has been executed by the City and MnDOT.

## Taxiway A Lighting & Signage Replacement - Design

The FY24 Entitlement Grant Agreement and MnDOT companion grant have been executed. A FY23 Supplemental Discretionary Grant Application for construction of the project was also submitted on May 2, 2024. This grant program is competitive, and no construction funding is guaranteed from the Supplemental Discretionary funding program. Announcement for Supplemental Discretionary grant recipients was anticipated in August 2024, but no announcement has been released by the FAA to date. Design will take place in 2024 with construction anticipated in 2025.
